| | Since the last Bulletin was issued, by-elections have taken place using the 2017 version of the e-count software and equipment, in the following councils: Aberdeenshire (4 November) Angus (29 November and 6 December) Fife (15 December) | | | |
| | • All of the counts were completed without any problems and the new reports were used. Again, we have seen a noticeable reduction in adjudication rates (typically in the mid-teens) compared to those typically seen when using the 2012 version of the system. One final by-election is scheduled prior to May 2017 and this will take place in East Ayrshire Council in January. | | | |

| | EASYPRINT WORKSHOP | | | |
| | • This time round, the main e-counting Framework contract includes provision for the printing of all station ballot papers and postal ballot packs. Idox are the supplier partner in charge of this element. Some authorities will already be Idox customers while others will not. | | | |

| | • As trailed in the last Bulletin, a workshop event to review EasyPrint and related printing issues, was held on 16 November at Pentland House in Edinburgh. This well-attended workshop session was led by the Idox team allowing all councils the opportunity to understand their approach, ask questions and to make Idox aware of their needs. The presentation slides are now available on the Portal which I hope election teams are beginning to see as a helpful resource. |

| | • As mentioned in the last Bulletin, a Print Working Group has been established to take the lead in assuring that all elements of ballot paper production, printing, proofing and distribution are properly addressed. At their first two meetings, the Group has reviewed the contingency and continuity arrangements with regard to the printing and distribution of ballot papers and postal vote packs. In addition, the Group has reviewed all the print products and will be making recommendations on these to the EMB. The Print Working Group will meet again on 13 January 2017. |

| | • As you may be aware, EMB Direction 9 relates to the 'Provision of Information' by councils relating to the elections in each of their wards. The purpose of this is to allow the EMB to compile a full analysis of results for each of the contests across all 32 councils. The collated data is to be published on the EMB website on 5 May providing Scotland-wide results immediately after the completion of all counts . The lack of such a resource resulted in some public and media criticism in 2012. |
