4	Scottish Parliamentary Elections 5 May 2016	Update from Scottish Government AM advised that the Scottish Parliament Election Order was planned for the end of September. It was noted that SOLAR would provide comments to the Scottish Government. Update from Electoral Commission It was noted that Guidance is dependent on the Conduct Order and that planning dates will be out from October.	
		Work is currently being carried out on the "TIME OUT TO GET IN" campaign which is taking place in all schools and colleges across Scotland from the 7-11 September. The event is supported by The Electoral Commission, Education Scotland, SOLACE, ADES, School Leaders Scotland, the EMB, the SAA, the Scottish Council for Independent Schools, Colleges Scotland and the Scottish Government Learning and aims to encourage 15-17 year olds to register to vote at the Scottish Parliament election on 5 May 2016.

EMB Role and Recommendations It was noted that the EMB will set recommendations on dates and issues surrounding poll cards and postal votes for elections. DMcG advised that he would create a template spreadsheet for the allocation of Regional Seats for RROs.	
5	Referendum on the UK's membership of the European Union	Update for the Electoral Commission In anticipation of the EU referendum, potential dates have been investigated. The EU Referendum Management Board (EURMB) has been set up along with a Referendum Delivery Group which has been established to support the CCO. Appointment of Regional Counting Officers Jenny Watson has been appointed as CCO and Andrew Scallan as DCO. There are 11 RCO's across Great Britain including a Chief Electoral Officer for Northern Ireland. The CCO intends to approach the management of the EU referendum in a similar way to that followed by the CCO for the Scottish Independence Referendum in September 2014. It is noted that MP has been appointment RCO Designate for Scotland and as such has scope to issue Directions. Draft European Union Referendum (Conduct) Regulations Copies of Responses to the Cabinet Office's Consultation on the Draft European Union Referendum (Conduct) Regulations from SOLAR Elections Working Group and SAA were tabled. It was noted that these responses were endorsed by the EMB.	

6	Scottish Local Government Elections 2017	eCounting for 2017 Local Government Elections Update from Scottish Government The evaluation panel will report their final scoring to the Project Board prior to forwarding to the Scottish Government. It was noted that the Contract is to start on 2 November 2015. Update from Local Government Liaison Consultant DMcG advised that both bidders were asked for further clarification on certain points. It was noted that this further clarification phase will not impact on the overall project timetable. It was agreed to defer the pens versus pencil issue until bidder in place.
