	• Count Venues – It has been highlighted to us recently that the Scottish Exam Diet (which starts on Tuesday 26 April and finishes on Wednesday 1 June 2022) is impacting on the availability of some Count Venues. Councils who are using schools (or other similar community premises) may wish to ascertain if the exam diet will impact on the use of Count Venues during the week of the poll and count, if you have not already done so.
	Count Visits/Surveys are progressing well - thank you for your co-operation.
	• Performance Testing - The final system performance tests, which were end-to-end test and used over 165k ballot papers took place last week. These were very successful – the system performed extremely well and all key performance requirements were met. All data extraction processes were undertaken, include production of the full suite of end of election reports and the transfer of these to portable drives for Council retention. The time taken to do this is much reduced from 2017, you will be pleased to hear. Full information on this process will be added to a future Q and A.
