 <u>Good Friday is a normal working day for Royal Mail in Scotland – there will be collections and deliveries</u> Prior to other holidays over that period, rather than the normal pre holiday shut down at 8pm the systems will be operating until 12 midnight to try to shift as much material as possible. Purple flashes on postal votes will be noticed and well treated Licenses- ROs to endeavour to ensure that licences are up to date and in place. However if they are out of date material will still be dealt with and the problem raised as a matter of urgency Also note that the first line of license can be revised to Counting Officer / Returning Officer at no charge Escalation is to be via specified local contacts wherever possible, not via sorting office. Sweep in place and to be paid for nationally (at a UK level) centrally If postal votes are handed over to Royal Mail on 18 April – as per CCO direction – it is expected that all electors should be in possession of votes by Good Friday – 22 April at the very latest. This fits in with the general principle that 96% of all first class post is delivered the next day. However, need to liaise closely with printers to facilitate process. Other specific issues raised from individual ROs to be pursued separately 	
 Legislation Scottish Parliament (Elections etc) Order 2010 – now in force Parliamentary Voting Systems and Constituencies Bill – still before the Lords however, at this point there is every expectation that the referendum will be on 5 May and Scotland Office encouraged all ROs to continue to prepare on that premise. Charges Order – still awaited. However the following points are clear: The provision for the Referendum will be as if it was a stand alone Referendum and the provision for the SP elections as if they were stand alone elections Costs likely to be split 50%:50% between the referendum and the SP elections
